About the Gallery

The Katharine Butler Gallery is one of Sarasota's most respected art galleries. Located in beautiful Towles Court, the gallery exhibits work in a wide range of mediums by local and national artists. Clientele includes Florida residents as well as visitors from around the world.

Juror

Adam Justice. Curator of Art at the Polk Museum of Art in Lakeland, FL.

Awards

Cash prizes for 1st and 2nd place.

Eligibility

Open to artists 18 years or older living in the United States. Original 2D and 3D artwork in any traditional medium, including photography, fiber, ceramics, metal, and glass, except video. Work must have been completed within the last three years. Each artist may submit up to three entries, not to exceed 42" in any dimension, including frame. **NO GICLEE COPIES OF ANY KIND.**

Entry Fee

A non-refundable entry fee of \$35 is charged to each artist. Payment may be made by check (made payable to the Katharine Butler Gallery) or by credit card and is due with application. We accept Visa, American Express, Discover, and Mastercard.

Only CDs Accepted

Images on CDs must be in jpeg format, approximately 6 x 9 inches, and at 300 dpi. **Please name the files with your full name, Entry number 1, 2, 3 and title of artwork.** CDs of accepted work will be retained by the gallery until the exhibition is over for publicity purposes. CDs of unaccepted work will be returned only if a 6 x 9 SASE is provided. Any accepted work that differs from the CD may be disqualified.

Hand-Delivery of Accepted Work

Accepted entries must be delivered between Tues – Sat., June 8 – 12, 2010 between 11:00 am. and 4:00 pm. Any work received after that time will be disqualified.

Shipping of Accepted Work

Shipped accepted entries must be received between Tues – Fri., June 8 – 11, 2010 between 11:00 am. and 4:00 pm. Shipped items are the artist's responsibility, and all accepted work must be shipped in a reusable sturdy carton and include pre-paid shipping labels to ensure its return. The Katharine Butler Gallery is not responsible for lost, stolen or damaged work during shipping. **DO NOT USE PACKING PEANUTS IN YOUR SHIPMENT.**

Presentation

Accepted 2D work should be suitably framed and ready for hanging with picture wire only. Museum wrapped pieces are also acceptable. Works that are not properly framed will be disqualified.

Exhibition

The exhibition will open Wed., June 16 and continue through Sat., July 10, 2010. A reception will be held Fri., June 18 from 6:00 – 10:00 pm. The artists and the public are invited to attend. All accepted work must remain in the Katharine Butler Gallery until the close of the exhibition.

Sales and Reproduction

All work must be for sale. The Katharine Butler Gallery receives a 50% commission on sales. The gallery reserves the right to reproduce accepted entries for publicity purposes. The Gallery reserves the right to offer up to 15% discount off the retail price to Interior Designers. Commissions will be paid from the discounted sales price.

Notification of Results

The results of the competition will be posted to our website by Friday April 30. Only those accepted will be posted.

Liability

All reasonable care will be given to work in the custody of the Katharine Butler Gallery. However, the gallery cannot assume responsibility for theft, damage or deterioration of work at any time.

Return of Work

Accepted entries must be picked up between July 13 – July 17, 2010 between 11:00 am and 4:00 pm. Work to be shipped must have a pre-paid shipping label and will be sent out by July 16. Any remaining work will incur a \$5.00/day storage fee.
